Dear Ambassador Waltz,

We write in advance of the United Nations' (UN) General Assembly meeting in New York City, beginning September 22, 2025. We are deeply concerned with the legitimacy the United Nations affords to the terrorist led Palestinian regime and their performative political actions. We ask that you remain steadfast in your advocacy for the United States and its greatest ally, Israel, and continue to condemn and highlight misinformation being perpetuated by representatives at the United Nations.

Hamas, with the help of the United Nations, has manufactured the perception of a famine in Gaza to serve as a false flag to undermine the reputations of both the United States and Israel. The UN has empowered Hamas to seize control of the aid brought in for the citizens of Gaza, hoarding the food for themselves and depriving the population of critical necessities. The United Nations has continued to enable a terroristic regime by turning a blind eye to its reprehensible use of starvation as a means to control its population and increase profit, and has thus become an accessory to the suffering of millions.

The United States and Israel have both tried relentlessly to deliver aid and food to assist the innocent victims of Hamas' siege on Gaza. Many aid efforts led by the Israel Defense Forces and the United States have been either rejected by the United Nations or seized by Hamas to sell for their own gain.<sup>2</sup> The United Nations has refused to work with the U.S. and Israel-backed *Gaza Humanitarian Foundation*.<sup>3</sup> The UN has demanded that the *United Nations Relief and Works Agency for Palestine Refugees* (UNRWA) handle the distribution of aid and relief, despite UNRWA's allowance of Hamas officials to hoard the resources.<sup>4</sup> Reports indicate that hundreds of truckloads of food are waiting at the border entry point to be distributed to citizens.<sup>5</sup> The United

Nations has continued to withhold this aid while amplifying the messaging of a famine perpetuated by Israel.

As the United States' Representative to the United Nations, you are equipped and empowered to resist the UN's efforts to cover up Hamas' human rights atrocities. When the United Nations turns a blind eye to the manufacturing of a famine to control a population, they turn away from the principles they were founded to uphold. The United States must be clear that we will not allow terrorism to present itself falsely as humanitarianism.

We urge you to utilize the full influence of your position to unequivocally condemn the dishonest rhetoric of the Palestinian regime and United Nations representatives that enable it. The reputations of the United States and its greatest ally are on the line.

Thank you for your attention to this pressing matter. We look forward to your leadership on this issue.
